DOGGYLAND LLC POLICIES, PROCEDURES AND RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT ("Agreement")

In consideration for my cat being permitted to be a client at a DOGGYLAND LLC for boarding, I make the following representations and agree to all of the following policies, procedures, terms and conditions:

1. DOGGYLAND LLC REQUIREMENTS. My cat meets the following requirements he/she: is four (4) months of age or older; he/she is spayed or neutered (if over six (6) months of age); is current on his/her Rabies, Distemper and Bordetella vaccinations; is in good general health and free of ticks and fleas; is not aggressive or protective of toys; meets all other municipal or state licensure and other requirements; is attending llc with a quick release collar

2. PERSONAL PROPERTY. I agree that Doggyland Llc shall not be responsible or liable for any lost, stolen, or damaged personal property belonging either to me or my cat. I also understand and agree that my cat's collar may be removed in the play area to prevent injury to any cat

3. AGGRESSIVE CATS. My cat is not aggressive. Although Doggyland Llc loves all cats, I understand that aggressive cats are not permitted to attend Doggyland Llc. If my cat acts aggressively or exhibits unacceptable behavior he/she may be separated from the other cats. Doggyland Llc uses reasonable efforts to consult the cat's owners about aggression and ways to address it, however aggressive cats may be asked not to return to Doggyland Llc. Such determinations shall be made at the sole discretion of Doggyland Llc.

4. ABANDONED CATS. Doggyland Llc is a place where all cats are loved and can romp and play. No cat may be abandoned at Doggyland Llc. I agree that I will not neglect to pick up my cat from Doggyland Llc by the time he/she is scheduled to leave without providing notification. Any cat that is left at Doggyland Llc without any contact, instruction or notification will be considered abandoned Doggyland Llc will, in its sole discretion, determine whether to try to re-home and adopt the cat from the Doggyland Llc or will relinquish the cat to an unrelated

shelter of its choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY CAT AT DOGGYLAND LLC, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY CAT AND WILL HAVE NO RECOURSE AGAINST DOGGYLAND LLC..

5. DUTY TO DISCLOSE. I have disclosed and shall continue to disclose on an ongoing basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my cat's ability to participate in play time or otherwise attend Doggyland Llc.

6. ACCEPTANCE AND ACKNOWLEDGEMENT OF PARTICIPATION RISK. I FULLY UNDERSTAND THAT: (a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND CATS, AS WELL AS BETWEEN CATS AND OTHER CATS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR CAT; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY, "RISKS"). I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY OR MY CAT'S PARTICIPATION IN PLAY, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF MY CAT. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLELLA (KENNEL COUGH) OR ANY OTHER FORM OF CONTAGIOUS ILLNESS.

7. VETERINARIAN LIABILITY AND CARE. I agree to allow Doggyland Llc to obtain medical treatment for my cat, if, in its sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest that my cat may need medical treatment. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT, AND FOR THE COST OF ANY TRANSPORTATION FOR THE PURPOSES OF SUCH TREATMENT, PROVIDED TO MY CAT.

8. PHOTOS. I agree to allow Doggyland to use photos they have taken of my cat, for advertising on the internet, print and television.

9. WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY EXPRESSLY WAIVE, DISCHARGE, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND DOGGYLAND LLC, AND THEIR INVITEES, SPONSORS, ADVERTISERS, MEMBERS, MANAGERS, OWNERS, OFFICERS, DIRECTORS, EMPLOYEES, VOLUNTEERS, INVITEES, AGENTS, AND ANY PARTIES OWNING, CONTROLLING OR HAVING ANY INTEREST IN DOGGYLAND LLC, AND ALL OTHER REPRESENTATIVES OR AGENTS (COLLECTIVELY "RELEASES") FROM AND AGAINST ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, COSTS, LOSSES, DAMAGES, EXPENSES OR DEMANDS (INCLUDING REASONABLE ATTORNEY'S FEES) OF EVERY CHARACTER WHATSOEVER ON ACCOUNT OF, ARISING OUT OF, RESULTING FROM OR RELATING IN ANY WAY TO (I) ANY ACT OR OMISSION OF THE RELEASES', INCLUDING NEGLIGENCE, AND (II) MY OR MY CAT'S PARTICIPATION IN BOARDING OR ACTIVITIES AT DOGGYLAND LLC, OR OTHERWISE. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE DOGGYLAND LLC FROM ANY DUTY TO PROTECT ME OR MY CAT(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF DOGGYLAND LLC CHOOSES TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED DOGGYLAND LLC FROM ANY DUTY TO PROTECT ME OR MY CAT(S).

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THE AGREEMENT AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THAT THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY CAT(S).
